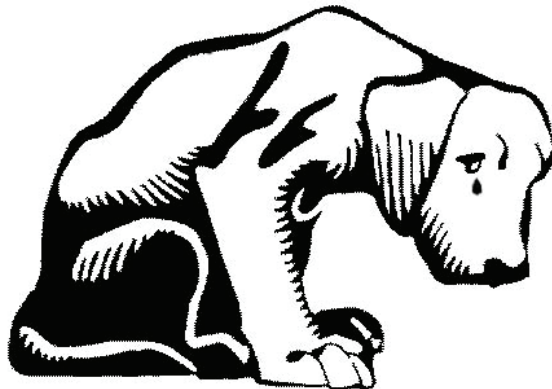

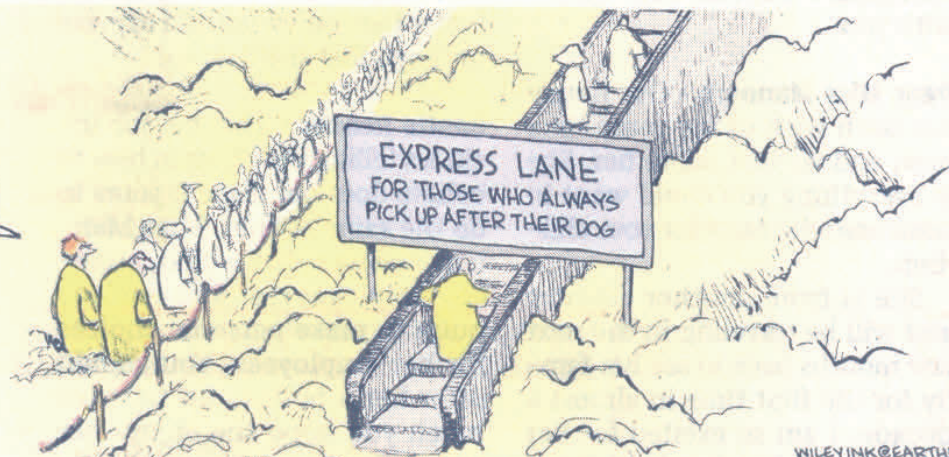
From Nancy Lincoln:
